### **Expectations**

- All parents and campers/students have the responsibility to treat one another, staff and property with respect.
- All parents and campers/students have the responsibility to act and behave in a way which does not endanger, intimidate or interfere with the participation of others.
- Campers/students have the responsibility to follow the instructions given by MCF staff.
- All parents and campers/students have the responsibility to behave in a way that does not threaten, endanger, intimidate or act out aggressively against our horses/staff.
- Gossiping/spreading rumors/drama is absolutely unacceptable behavior in any form.

# **MCF Equestrian Code of Conduct**

**Rules** – the following forms of behavior are considered a violation of this document and are unacceptable and could result in the immediate suspension and/or dismissal of camper(s) and/or student(s) of MCF Equestrian:

- Cigarettes, alcohol, non-prescribed drugs, weapons and pornographic material must not be brought onto MCF's property.
- Using language which is offensive, sexist or racist.
- Fighting, bullying or any other forms of aggressive behavior.
- Behaving in a manner which is potentially dangerous to self and others.
- Behaving in a manner which damages or vandalizes the property of others or MCF Equestrian.
- Spreading rumors/ gossip/drama in any form.
- Talking negatively against MCF Equestrian/staff.

Any breach of the Rules or the Code of Conduct will initiate a disciplinary action. MCF Equestrian reserves the right to suspend and/or dismiss a camper/student's participation in any MCF Equestrian activities, camp programs, lessons and/or shows without refund, if such disciplinary action is required. Before such a decision is fully made, the camper/student and parent/guardian will meet with Administrations Manger/Owner/Trainer to determine the best course of action for both the camper/ student and MCF Equestrian Center.
